A \$1,500 scholarship is reflected on the "oldest child" tuition in the above cost per child chart as the following:

- \$500.00 scholarship if the family attends and participates in Mass at St. Vincent de Paul parish. Attendance will be tracked through offertory collection using your parish envelope or the Parish Online Offertory System. Participating members of other parishes could be eligible for a scholarship through their parish. Families are encouraged to discuss their eligibility for this scholarship and additional assistance with their parish.

**2023-2024 FEES (All are Non-Refundable):**

- 1) **Tuition Commitment Form/Registration Fee: \$100 PER FAMILY**, non-refundable, will be charged to your FACTS account on September 1 **IF FORM IS TURNED IN BY April 28.**
  - a) **Tuition Commitment Form/Registration Fee: \$150 PER FAMILY**, non-refundable, will be charged to your FACTS account on September 1 **IF FORM IS TURNED IN AFTER April 28.**
- 2) Book/Technology Fee of \$200 per person will be charged to your FACTS on September 1, 2023.
- 3) Retreat Fees will be charged to your FACTS on September 1, 2023.
  - a) Grades 9-11: \$30 per student
  - b) Grade 12: \$175 per student
